## Corning hikes impact fee

**CORNING** The City Council approved an increase in the water well development impact fee and issued several proclamations Tuesday.

It allows for six wells, City Engineer Ed Anderson said of the increase. That's what we projected to be needed in the next 20 years.

Mayor Gary Strack said he was initially opposed to raising anything, but after seeing the cost for the new well going in at Clark Park, he changed his mind.

The fees were last updated in July 2005 and the new fee will not go into effect for 60 days, said City Manager Steve Kimbrough.

The public hearing went quickly with no one stepping forward to comment on the increase, which is up from \$709 per equivalent dwelling unit to \$1,074.

A public hearing was held for an ordinance that would enact new building codes within the city.

The staff report shows that two new codes, not previously applied in Corning, are among the many updates adopted. The first is the California Residential Code, which is for one- and twofamily homes and town houses and includes the requirement of sprinkler systems to all new construction.

The second, the Green Building Standards Code, implements mandatory measures aimed at curbing greenhouse gas emissions, energy conservation and other environmental impacts of new construction. A second reading is expected to be set for the Oct. 25 meeting.

The Tehama County Young Marines and Tehama County Department of Education accepted a proclamation of Oct. 23-31 as Red Ribbon Week.

Tex Ash, Pat Scott and Rich Reynolds of the group Loosely Strung came to accept the proclamation of Oct. 20-22 as Western Open Fiddle Week.

The group played for the council and encouraged them to come out to the event.
